JUDGMENT

Judgment is hereby entered in accordance with the terms of this Court’s Order Granting Final Approval of Proposed Settlement and this Court’s Order Granting Attorneys’ Fees, Reimbursement of Costs and Expenses, and Incentive Awards, both of which are dated August 24, 2018. (Collectively, the two orders are referred to as the Final Approval Orders.)

The Settlement Class is defined as: All persons who were assessed a Late Payment Charge<sup>1</sup> or an Erroneous Late Payment Charge that was paid from December 1, 2008, through February 21, 2018.

97 members of the Settlement Class submitted timely and valid requests to be excluded from the Settlement Class. The Settlement Class governed by the Court’s Final Approval Order and this Judgment does not include those 97 individuals. A list of members who submitted timely and valid requests for exclusion is attached here as Exhibit A. See August 3, 2018 Thomas Decl., Ex. C.

Plaintiffs and the Settlement Class shall take nothing from the Released Defendant Parties except as set forth in the Second Amended Stipulation of Settlement and the Final Approval Orders.


